

## **OFFICIAL SWEEPSTAKES RULES**

### **1. INTRODUCTION**

Dial Global Radio Networks, Inc. ("Sponsor") is offering the "**Garth Brooks LIVE in Las Vegas**" Sweepstakes. **NO PURCHASE OR OBLIGATION IS NECESSARY. VOID WHERE PROHIBITED.** By entering this Sweepstakes, entrants agree to abide by all terms of these Official Sweepstakes Rules and the decisions of Sponsor, whose decisions shall be final and binding.

### **2. ELIGIBILITY**

This Sweepstakes is open only to individuals who are twenty-one (21) years of age or older and legal residents of the United States at the time of entry. Individuals who have won a prize from Sponsor within 180 days prior to March 4<sup>th</sup>, 2010 are NOT eligible.
